## Mandatory Professional Licensure Disclosure

Norwich University offers a program of study, which, if successfully completed, results in a *Master's of Science in Nursing- with concentrations in Acute Care Nurse Practitioner-Adult Gerontology, Family Nurse Practitioner, and Psychiatric Mental Health Nurse Practitioner*. This program is designed to prepare students to sit for certification in one of these concentrations and apply for a state license to practice.
